#### **COMPANY PROFILE**

The concept of formation of Industrial Corridors has been envisaged on the backbone of major transportation corridors like Eastern & Western Dedicated Freight Corridors and some of the recently announced freight corridors i.e. East West, East Coast and North South, Expressways and National Highways, proximity to ports, airports, etc. The objective is to create greenfield smart industrial cities with sustainable, 'plug n play', ICT enabled utilities to facilitate the manufacturing investments into the country by providing quality, reliable, sustainable and resilient infrastructure for the industries.

### **JOB DESCRIPTION AND KEY RESPONSIBILITIES:**

- Designing, development, implementation and maintenance of System policies and procedure related to ICT services, including procurement and asset management;
- Responsible for develop and manage the planning and budgeting for the ICT services;
- Workout on new ICT opportunities and Cost exercise to be done to adopt new cutting edge technologies in coordination with different stakeholders including State Govt. / Nodal Govt. bodies / authorities.
- Responsible for preparing scope of work for ICT RFP documents, understanding of overall ICT strategy and System Architecture;
- Need to evaluate various ICT components like smart street lighting, smart parking, healthcare, and Education related technology;
- Responsible for making a comparison of various e-governance initiatives, other smart city business model, terms of reference, scope of work, designing of ICT systems or sub-systems,
- Providing inputs and assistance to SPVs / PMCs / ICT consultants for preparation of documents with the learning experiences of other nodes which are in advance stage of implementation.
- Responsible to evaluate and validation of Approach and Methodology of ICT projects including Logistics Data Bank project, Unified Logistics Interface Platform, PM Gati Shakti.
- Bids Exercise control and monitoring of corporate ICT projects progress;
- Oversee ICT special projects, including planning, scheduling, managing and progress reporting for ICT implementations;
- Provide necessary support for ICT related project specific support like website, mail and other applications etc. with proper plans to host/ migrate in secured NIC cloud infrastructure and related other activities following the GOI guidelines.
- Preparation of response for Govt. Department / Ministry's correspondences and follow-up on ICT related matters like Data Management and Analytics, advisories related to GOI Guidelines, IT Security and compliances etc.

## **MINIMUM REQUIREMENTS**
