JOB DESCRIPTION

He/she will report to Senior Officials of NICDC. This role requires multifunctional approach and co-ordination with various State Governments & their nodal agencies and requires supervision at various levels from projects planning to implementation. This job will also require close interaction with different Ministries of Government of India from time to time.

KEY RESPONSIBILITIES

- Manage large transportation planning studies, including multimodal corridor planning studies, Planning and Environmental Linkages Studies, and Transportation Master Plans.
- Lead projects involving traffic design in urban areas, including street layout, junction design review, parking facilities, cycling paths, and pedestrian areas.
- Draft reports and studies related to Urban Transport projects, such as Comprehensive Mobility Plans (CMPs), Parking Studies, Detailed Project Reports (DPRs), and traffic improvements.
- Suggest modifications in reports submitted by consultants and review revised versions.
- Review Detailed Project Reports regarding current road conditions, traffic, and the development of new roads considering future city demand.
- Conduct cost estimation for projects and develop implementation schedules.
- Prepare or review engineering studies and specifications.
- Represent jurisdictions in legislative or administrative approval processes for land development projects.
- Prepare necessary documents to obtain project approvals or permits.

- Define or update information such as urban boundaries or the classification of roadways.
- Analyze transportation-related consequences of federal and state legislative proposals.
- Analyze data from traffic counting programs.
- Review development plans for transportation system effects, infrastructure requirements, and compliance with applicable transportation regulations.
- Prepare reports or recommendations on transportation planning.
- Participate in public meetings or hearings to explain planning proposals, gather feedback from affected parties, and achieve consensus on project designs.
- Document and evaluate the needs and costs of intelligent transportation projects.
- Review design ideas for new or improved transport infrastructure, such as junction improvements, pedestrian projects, bus facilities, and car parking areas.
- Design transportation surveys to identify areas of public concern.
- Analyze and interpret data from traffic modeling software, geographic information systems, and associated databases.
- Collaborate with consultants to research, analyze, or resolve complex transportation design issues.
- Recommend transportation system improvements or projects based on economic, population, land-use, or traffic projections.
- Define regional or local transportation planning problems or priorities.
- Analyze information related to transportation, such as land use policies, environmental impacts of projects, or long-range planning needs.
- Collaborate with other professionals to develop sustainable transportation strategies at local, regional, or national levels.
- Demonstrate the ability to work both as part of a multi-disciplinary team and independently to solve issues.

MINIMUM REQUIREMENTS

- 3. **Educational Qualification**: Bachelor's degree in Engineering or Planning and Post Graduate in Transport Planning/Transportation Engineering or similar degree from a recognized university with a good academic record.
- 4. **Experience:** Minimum 07 years of post-qualification experience.

- Knowledge of project structuring and procurement of large infrastructure projects under PPP/EPC mode of delivery will be an added advantage.

- Familiar with relevant codes and guidelines of IRC and MORTH.

- Demonstrated ability to work well in a fast-paced environment and to juggle multiple assignments with little supervision.
- Highly organized and detail-oriented; experience in managing complex processes or projects.
