# 1. INTRODUCTION

# 1.1 Background

1.1.1 Government of India has envisaged the development of Delhi Mumbai Industrial Corridor (DMIC) along the alignment of proposed Multi-modal High Axle Load Dedicated Freight Corridor between Delhi and Mumbai, covering an overall length of 1483 km. For development of Dholera, A Special Purpose Vehicle is created as a joint venture company by the Government of India [through National Industrial Corridor Development and Implementation Trust (NICDIT) (erstwhile DMIC Project Implementation Trust Fund)] and the Government of Gujarat [through Dholera Special Investment Regional Development Authority (DSIRDA)] on 28th January, 2016, under Companies Act, 2013 and rules made thereunder in the name of 'Dholera Industrial City Development Ltd' (DICDL). The Company comprises of 51% shareholding of Government of Gujarat through DSIRDA and 49% stake of Government of India through NICDIT (Erstwhile DMIC Trust). Dholera is the first city in India where all underground utilities like Gas, ICT, Power, Portable water, recycled water, sewer pipes and storm water are pre-planned for complete development with the capacity of handling the growing demands of the city.

Under the overall Implementation and Phasing Plan, the Activation area is identified for early start-up of development. The Activation Area is spread over approximately 2254 ha. The area can be accessed by the existing SH6 via the Coastal Road in north as can be seen in the DSIR plan.

It has on offer a location & infrastructure that will ensure establishment of efficient & profitable businesses. DICDL has initiated development of a fully master planned, smart industrial city on an initial area of 22.54 Sq.km and is gearing up for operationalizing India's largest Greenfield development within the Dholera Special Investment Region. Dholera, located just about 100 KMS South West of Ahmedabad, Gujarat's largest city, is an ideal location for large scale manufacturing with big, flat parcels of land, clear land titles & accompanied by best-in-class infrastructure. An efficient transportation system, an access-controlled expressway corridor including a Metro rail, will bring Dholera in close proximity of Ahmedabad; also making it into a developed location.

It is well suited for industries that require and value, plug & play infrastructure; industries that require an eco-system like Defense, Auto companies that require vendor parks, or capital goods that require efficient external infrastructure to move their cargo. It is all getting ready at Dholera. Plug & Play infrastructure, that is, infrastructure at door step is being implemented by renowned private engineering companies. It includes a well-planned, complete utility infrastructure system for Power at various levels including solar & wind; Water Management includes pure water, recycling of waste water & its distribution; PNG; solid waste collection & disposal systems; 2 to 6 lane Roads with walk-ways for pedestrians, street lighting & furniture; Smart-ICT network & so on.

It is well connected to Airports, Sea Ports & Rail terminal for excellent man & material movement. All Government of Gujarat incentive schemes are applicable & businesses at Dholera will benefit from these. Dholera will ensure availability of skills for businesses with efficient transportation reducing travel time with Ahmedabad. Skilling centers & institutes for higher education within Dholera will also make skilled manpower available.

As part of this endeavor, the Dholera Industrial City Development Limited (DICDL) in the capacity of the Client has decided to invite submission of technical and commercial bids from interested applicants, meeting the minimum eligibility criteria as given under, to undertake the 'Demonstration of Energy Efficient Desalination Plant' at Dholera Special Investment Region

(DSIR).Government of India has envisaged the development of Delhi Mumbai Industrial Corridor (DMIC) along the alignment of proposed Multi-modal High Axle Load Dedicated Freight Corridor between Delhi and Mumbai, covering an overall length of 1483 km.

**Estimated cost of Project:** The estimated cost for Part A of the scope of work is INR 5 Crores and for Part B will be INR 12 Crores.

1.1.2 The selected Bidder (the "Contractor") shall be responsible for designing, engineering, procurement, construction, integration, commissioning and operation maintenance of energy efficient seawater desalination technologies for a period of minimum 12 months (Part A, Scope of work). Provision of seawater intake, brine reject and produced water management and land levelling and minimum road infrastructure inside the demonstration sites for a period of minimum 12 months from the date of commissioning of part A scope of work. (Part B scope of work). The project will be done under and in accordance with the provisions of an engineering, procurement and construction contract (the "EPC Agreement") to be entered into between the Contractor and the Employer in the form provided by the

- 1.1.4 The estimated cost of the Project (the "**Estimated Project Cost**") has been specified in clause 1.1.1 above. The assessment of actual costs, however, will have to be made by the Bidders.
- 1.1.5 The EPC Agreement sets forth the detailed terms and conditions for award of the project to the Contractor, including the scope of the Contractor's services and obligations.
- 1.1.6 The statements and explanations contained in this RFP are intended to provide a better understanding to the Bidders about the subject matter of this RFP and should not be construed or interpreted as limiting in any way or manner the scope of services and obligations of the Contractor set forth in the Agreement or the Employer's rights to amend, alter, change, supplement or clarify the scope of work, the work to be awarded pursuant to this RFP or the terms thereof or herein contained. Consequently, any omissions, conflicts or contradictions in the Bidding Documents including this RFP are to be noted, interpreted and applied appropriately to give effect to this intent, and no claims on that account shall be entertained by the Employer.
- 1.1.7 The Employer shall receive BIDs pursuant to this RFP in accordance with the terms set forth in this RFP and other documents to be provided by the Employer pursuant to this RFP (collectively the "Bidding Documents"), and all BIDs shall be prepared and submitted in accordance with such terms on or before the BID due date specified in Clause 1.3 for submission of BIDs (the "BID Due Date").

# 1.2 Brief description of Bidding Process

1.2.1 The Employer has adopted a Single-stage Two Part process (collectively referred to as the "Bidding Process") for selection of the bidder for award of the Project. Under this process, the bid shall be invited under two parts. Eligibility and qualification of the Bidder will be first examined based on the details submitted under first part (Technical Bid) with respect to eligibility and qualifications criteria prescribed in this RFP. (The "Bidder", which expression shall, unless repugnant to the context, include the members of the Joint Venture). Prior to making an Application, the Bidder shall pay to the Employer a sum of Rs 20,000/-( Rupees Twenty thousands) Only) Plus 18 % GST totaling Rs 23,600/- only) as the cost of Tender Fee.

The Financial Bid under the second part shall be opened only for those Bidders whose Technical Bids are responsive to eligibility and qualifications requirements as per this RFP.

Government of India has issued guidelines (see Appendix-V) for qualification of bidders seeking to acquire stakes in any public sector enterprise through the process of disinvestment. These guidelines shall apply *mutatis mutandis* to this Bidding Process. The Employer shall be entitled to disqualify a Bidder in accordance with the aforesaid guidelines at any stage of the Bidding Process. Bidders must satisfy themselves that they are qualified to bid, and should give an undertaking to this effect in the form at Appendix-IA.

- 1.2.2 Interested bidders are being called upon to submit their Bid in accordance with the terms specified in this Bidding Document. The Bid shall be valid for a period of not less than 180 days from the date specified in Clause 1.3 for submission of BIDs (the "Bid Due Date").
- 1.2.3 The Bidding Documents include the draft Agreement for the Project. The Preliminary Design prepared by the Employer/ consultants of the Employer (the "Preliminary Design Details") will also be provided to the Bidders, the aforesaid documents and any addenda issued subsequent to this RFP Document, will be deemed to form part of the Bidding Documents.
- 1.2.4 A Bidder is required to deposit, along with its Bid, a bid security (i) for Part A INR,5,00,000/-(Rupees Five Lakhs Only) and (ii) for Part B INR. 12,00,000/- (Rupees Twelve Lakhs Only) and for both the bid security shall be INR. 17,00,000/- (Rupees Seventeen Lakhs Only)(the "Bid Security"), refundable no later than 180 days from the Bid Due Date, except in the case of the selected Bidder whose Bid Security shall be retained till it has provided a Performance Security under the Contract. The Bidders will have to provide Bid Security in the form of a Demand draft or bank guarantee issued by any scheduled bank in India and having a minimum net worth of Rs. 1000 Crore or any other bank acceptable to the Employer and in such event, the validity period of the bank guarantee shall not be less than 240 (two hundred forty) days from the Bid Due Date, inclusive of a claim period of 60 (sixty) days, and may be extended as may be mutually agreed between the Employer and the Bidder from time to time. The Bid shall be summarily rejected if it is not accompanied by the Bid Security.
- 1.2.5 Bidders are advised to examine the Project in greater detail, and to carry out, at their cost, such studies as may be required for submitting their respective Bids for award of the contract including implementation of the Project.
- 1.2.6 Bids will be evaluated for the Project on the basis of the lowest cost required by a Bidder for implementing the Project (the "Bid Price") for scope of work as mentioned in part B. However, for Part A scope of work the project will be awarded on the innovativeness of the project and its contribution to an energy efficient, cost competitive and environmental friendly seawater desalination. The selection of projects under Part A will be done by a team of desalination experts who will review the technologies submitted by the individual bidders against the Key Performance Indicators (KPI"s) mentioned in the tender document. The total time allowed for completion of construction under the Agreement (the "Construction Period") and the period during which the Contractor shall be liable for maintenance and rectification of any defect or deficiency in the Project after completion of the Construction Period (the "Defect Liability Period") shall be pre-determined, and are specified in the draft Agreement forming part of the Bidding Documents.

In this RFP, the term "Lowest Bidder" for Part A scope of work shall mean the bidder who is

quoting the merit of technology and novelty of the processes for energy efficient, environment friendly and cost competitive seawater desalination processes. However for Part B scope of work, "Lowest Bidder" mean the bidder who has quoted the lowest price for the complete scope of work as mentioned in Part B scope of work of this tender document.


- 1.2.7 Generally, the compliant Bidder who quotes the lowest bid price shall be the selected Bidder. However in this tender for Part A 'scope of work', multiple bidders can be selected based on the novelty of the process and contribution to the energy improvements and cost competitiveness of the desalination processes.




Figure 1: Tentative locations of the intake, reject and the proposed experimental site

# 2. INSTRUCTIONS TO BIDDERS

# A. GENERAL

### 2.1 Scope of Bid

2.1.1 Part A: Demonstration of energy efficient, cost competitive and environment friendly seawater desalination technologies at AA in DSIR for a period of minimum 12 months.

Part B: Provision of resources for seawater intake system, brine management system and utility lines for the demonstration of technologies as per scope of work of Part A. Part B scope of work include levelling of plots to protect inundation during high-low tide and minimum road network inside the demonstration sites.

The scope of work in Part A and Part B will have to include operation and maintenance for a period of 12 months. Part B operation and maintenance period will start 12 months from the commissioning date of Part A scope of work.

Bidders should keep in mind a period of additional 2 months of operation after the period of standard operation and maintenance period of 12 months. If there are any operational delays during the period of 12 months, the project will get extended accordingly to account 12 months of operation in total.

Bidders can quote for Part A and /or Part B or Vice versa. Bidders can submit for multiple technologies for Part A scope of work. However these submissions will be considered as separate proposals and reviewed separately.

# 2.2 Eligibility of Bidders

- 2.2.1 For determining the eligibility of Bidders for their qualification hereunder, the following shall apply for Part A
  - (a) The bidder should have designed, fabricated and installed energy efficient, cost effective and environmentally friendly seawater desalination systems (one of at least 5,000 LPD capacity) and a minimum demonstrable R&D experience of 5 years with various desalination technologies. AND
  - (b) They should have participated in Government projects / National / International funded projects of which at least one is of a value not less than Rs. 2 crores, over the last 5 years.
  - (c) OR
  - (d) The bidder should have prior experience on integration of renewable energy resources as a primary or/and secondary source for power / heat source or both in industry applications.
  - (e) The bidder should be able to prove through the operation and maintenance of the plant that the new technology suggested by the bidder is more efficient than existing technologies in terms of cost effectiveness, energy efficiency and environment friendliness.. For all the eligibility conditions the bidder should submit sufficient documents as proof of evidence.

For determining the eligibility of Bidders for their qualification hereunder, the following shall

apply for Part B.

- (f) The bidder should have designed, built and operated seawater e intake brine reject and produced water utility systems in large desalination projects of a minimum capacity of 2,00,000 LPD.
- (g) The bidder should have done prior approval procedures, for seawater intake, brine management mechanisms/ reject mechanisms in seawater desalination projects as per Government of India prevailing norms and conditions. The bidder should submit sufficient proof of evidence for all the eligibility conditions for Part B scope of work.

# 2.2.2 Parameters for assessing the technical capabilities

The bidder / consortium is expected to possess relevant and adequate professional experience in such projects as outlined elsewhere in this document. The parameters to be considered for assessing the technical capabilities and the maximum scores to be assigned for each parameter are detailed as below.

- 2.2.4 For determining the eligibility of Bidders for their qualification hereunder, the following shall apply:
  - (a) The Bidder may be a single entity or a group of entities (the "Joint Venture"), coming together to implement the Project. However, a Bidder, applying individually or as a member of a Joint Venture, as the case may be, cannot be member of another group of entity. The term Bidder used herein would apply to both a single entity and a Joint Venture.
  - (b) A Bidder may be a company incorporated under the Indian Companies Act, 1956/2013 or a combination of companies with a formal intent to enter into a Joint Venture agreement or under an existing agreement to form a Joint Venture. A Joint Venture shall be eligible for consideration subject to the conditions set out in Clause 2.2.6 below.
  - (c) A Bidder shall not have a conflict of interest (the "Conflict of Interest") that affects the Bidding Process. Any Bidder found to have a Conflict of Interest shall be disqualified. A Bidder shall be deemed to have a Conflict of Interest affecting

# the Bidding Process, if:

- (i) the Bidder, its Member or any constituent thereof and any other Bidder, its Member or any constituent thereof have common controlling shareholders or other ownership interest; provided that this disqualification shall not apply in cases where the direct or indirect shareholding of a Bidder, its Member thereof (or any shareholder thereof having a shareholding of more than 5 per cent of the paid up and subscribed share capital of such Bidder, Member, as the case may be), in the other Bidder, its Member is less than 5 per cent of the subscribed and paid up equity share capital thereof; provided further that this disqualification shall not apply to any ownership by a bank, insurance company, pension fund or a public financial institution referred to in section 4A of the Companies Act 1956/2013. For the purposes of this Clause 2.2.1, indirect shareholding held through one or more intermediate persons shall be computed as follows: (aa) where any intermediary is controlled by a person through management control or otherwise, the entire shareholding held by such controlled intermediary in any other person (the "Subject Person") shall be taken into account for computing the shareholding of such controlling person in the Subject Person; and (bb) subject always to sub-clause (aa) above, where a person does not exercise control over an intermediary, which has shareholding in the Subject Person, the computation of indirect shareholding of such person in the Subject Person shall be undertaken on a proportionate basis; provided, however, that no such shareholding shall be reckoned under this sub-clause (bb) if the shareholding of such person in the intermediary is less than 26% of the subscribed and paid up equity shareholding of such intermediary; or
- (ii) a constituent of such Bidder is also a constituent of another Bidder; or
- (iii) such Bidder, or any Associate thereof, receives or has received any direct or indirect subsidy, grant, concessional loan or subordinated debt from any other Bidder, or has provided any such subsidy, grant, concessional loan or subordinated debt to any other Bidder, its Member thereof; or
- (iv) such Bidder has the same legal representative for purposes of this Bid as any other Bidder; or
- (v) such Bidder, or any Associate thereof has a relationship with another Bidder, or any Associate thereof, directly or through common third party/ parties, that puts either or both of them in a position to have access to each other's' information about, or to influence the Bid of either or each other; or
- (vi) Such Bidder or any Associate thereof, has participated as a consultant to the Employer in the preparation of any documents, design or technical specifications of the Project.
- (d) A Bidder shall be liable for disqualification if any legal, financial or technical adviser of the Employer in relation to the Project is engaged by the Bidder, or any of its Members, as the case may be, in any manner for matters related to or incidental to the Project. For the avoidance of doubt, this disqualification shall not apply where such adviser was engaged by the Bidder, its Member in the past but its assignment expired or was terminated 6 (six) months prior to the date of issue of this RFP.

- (e) Profitability: The Bidder firm shall be profit (net) making firm and shall have made profit at least in three financial years out of the last five financial years prior to submitting the Bid. The Bidder should submit attested copies of auditor's report. In case of Joint Venture, the total profitability shall be the sum of the individual member.
- 2.2.5 To be eligible to bid, a Bidder, shall fulfil the following conditions of eligibility:
  - (A) Technical Capacity: (AS EXPLAINED ABOVE)
  - (B) Financial Capacity:
    - **a.** Construction Turnover: Minimum Average Turnover should be 3 Crore per annum for three immediately preceding financial year for Part A scope of work . The minimum consortium average turnover should be 10 crore per annum for three immediately preceding financial years for Part B scope of work.
    - **b.** (i) **Net Worth:** The Bidder shall have a minimum Net Worth (the **'Financial Capacity'**) of [Rs. 3 Crore. (Rs. Three Crores Only)] at the close of the preceding financial year for part A scope of work. For part B scope of work, the bidder should have a net worth of minimum 10 (Ten) crores in the preceding financial year.
    - (ii) The bidder (or any member of the JV) should be financially sound and should have not applied for Corporate Debt Restructuring (CDR) during last 5 (five) years.
    - (iii) Liquid assets and/ or credit facilities of not less than 5 Crore for applying Part A scope of work and not less than 20 crore for applying part B scope of work.

All the above items should be certified by the Statutory Auditor / CA of the company.

- 2.2.6 In case of a Joint Venture (not exceeding 3 entities):,
  - (i) The Threshold Technical Capacity and Financial Capacity of all the Members of Joint Venture would be taken into account for satisfying the above conditions of eligibility. Further, Lead Member shall meet at least 75% requirements of Technical and Financial Capacity required as per Clause 2.2.2 and each of other JV members shall meet at least 25% requirement of Technical and Financial capacity as per Clause 2.2.2. For avoidance of doubt it is further clarified that the Joint Venture must collectively and individually satisfy the above qualification criteria.
  - (ii) For requirement of 2.2.2, the Threshold Technical Capacity should have been completed from the Eligible Projects specified in RFP by any of the JV members.
- 2.2.7 The Bidder shall enclose with its Bid, to be submitted as per the format at Appendix-IA, complete with its Annexes, the following:

- (i) Certificate(s) from its statutory auditors \(^1\) Chartered Accountant or the concerned client(s) stating the payments received during the past 5 years, in respect of the Eligible Projects. In case a particular job/ contract has been jointly executed by the Bidder (as part of a Joint Venture), it should further support its claim for the payments received or construction carried out by itself in the Projects as applicable the share in work done for that particular job/ contract by producing a certificate from its statutory auditor or the client; and
- (ii) certificate(s) from its statutory auditors/Chartered Accountant specifying the net worth of the Bidder, as at the close of the preceding financial year, and also specifying that the methodology adopted for calculating such net worth conforms to the provisions of this Clause 2.2.4 (ii). For the purposes of this RFP, net worth (the "Net Worth") shall mean the sum of subscribed and paid up equity and reserves from which shall be deducted the sum of revaluation reserves, miscellaneous expenditure not written off and reserves not available for distribution to equity shareholders.
- 2.2.8 The Bidder should submit a Power of Attorney as per the format at Appendix- II, authorizing the signatory of the Bid to commit the Bidder. In the case of a Joint Venture, the Members should submit a Power of Attorney in favor of the Lead Member as per format at Appendix-III.
- 2.2.9 In case the Bidder is a Joint Venture, it shall comply with the following additional requirements:
  - (a) Number of members in a Joint Venture shall not exceed 3 (three) including lead partner;
  - (b) Subject to the provisions of clause (a) above, the Bid should contain the information required for each Member of the Joint Venture;
  - (c) Members of the Joint Venture shall nominate one member as the lead member (the "Lead Member"). Lead Member shall meet at least 75% requirement of Technical and Financial Capacity required as per Clause 2.2.2. The nomination(s) shall be supported by a Power of Attorney, as per the format at Appendix-III, signed by all the other Members of the Joint Venture;
  - (d) The Bid should include a brief description of the roles and responsibilities of individual members, particularly with reference to financial, technical and defects liability obligations;
  - (e) An individual Bidder cannot at the same time be member of a Joint Venture submitting for bid. Further, a member of a particular Bidder Joint Venture cannot be member of any other Bidder Joint Venture submitting for bid;
  - (f) The Lead Member shall itself undertake and perform at least 30 (Thirty) per cent scope of the proposed Project.
  - (g) Members of the Joint Venture shall have entered into a binding Joint Bidding Agreement, substantially in the form specified at Appendix-IV (the "Jt. Bidding Agreement"), for the purpose of making the Bid and submitting a Bid. The Jt. Bidding Agreement, to be submitted along with the Bid, shall, inter alia:
    - (i) convey the commitment(s) of the Lead Member in accordance with this

- RFP, in case the contract to undertake the Project is awarded to the Joint Venture:
- (ii) clearly outline the proposed roles and responsibilities, if any, of each member:
- (iii) commit the approximate share of work to be undertaken by each member;
- (iv) include a statement to the effect that all members of the Joint Venture shall be liable jointly and severally for all obligations of the Contractor in relation to the Project until the Defects Liability Period is achieved in accordance with the EPC Agreement; and
- (h) Except as provided under this RFP and the Bidding Documents, there shall not be any amendment to the Jt. Bidding Agreement without the prior written consent of the Employer.
- 2.2.10 Any entity which has been barred by the Central/ State Government, or any entity controlled by it, from participating in any project, and the bar subsists as on the date of Bid, would not be eligible to submit a Bid, either individually or as member of a Joint Venture.
- 2.2.11 Any Bidder including any Member should, in the last 3 (three) years, have neither failed to perform on any contract, as evidenced by imposition of a penalty by an arbitral or judicial Employer or a judicial pronouncement or arbitration award against the Bidder or Member, as the case may be, nor has been expelled from any project or contract by any public entity nor have had any contract terminated by any public entity for breach by such Bidder or Member.
- 2.2.11.1 The Bidder including any Member shall provide details of all their on-going projects along with stage of litigation, if so, against the Employer / Governments.
- 2.2.11.2 The Bidder including any member shall also provide details of on-going process of blacklisting if so, under any contract with Employer / Government.
- 2.2.11.3 The Employer reserves the right to reject an otherwise eligible bidder on the basis of the information provided under clause 2.2.8. The decision of the Employer in this case shall be final.
- 2.2.12 The Technical Capacity and Net Worth of the Bidder/ Members in case of Joint Venture shall be computed under
- 2.2.13 The following conditions shall be adhered to while submitting the Bid:
  - (a) Bidders should attach clearly marked and referenced continuation sheets in the event that the space provided in the prescribed forms in the Annexes is insufficient. Alternatively, Bidders may format the prescribed forms making due provision for incorporation of the requested information;
  - (b) information supplied by the Bidder (or other constituent Member if the Bidder is a Joint Venture) must apply to the Bidder, Member named in the Bid.;

- (c) in responding to the bid submissions, Bidders should demonstrate their capabilities in accordance with Clause 3.1 below; and
- (d) in case the Bidder is a Joint Venture, each Member should substantially satisfy the bid requirements to the extent specified herein.
- (e) in case the Bidder does not have the relevant experience for any specific element of the project, it shall be deemed to have given an undertaking to engage specialized personnel/sub-contractors in accordance with the Agreement.
- 2.2.14 While Qualification is open to persons from any country, the following provisions shall apply:
  - (a) Where, on the date of the Bid, not less than 15% (fifteen percent) of the aggregate issued, subscribed and paid up equity share capital in a Bidder or its Member is held by persons resident outside India or where a Bidder or its Member is controlled by persons resident outside India (Details are to be furnished in as prescribed); or
  - (b) if at any subsequent stage after the date of the Bid, there is an acquisition of not less than 15% (fifteen percent) of the aggregate issued, subscribed and paid up equity share capital or control, by persons resident outside India, in or of the Bidder or its Member/ Partner;

then the Qualification of such Bidder or in the event described in sub clause (b) above, the continued Qualification of the Bidder shall be subject to approval of the Employer from national security and public interest perspective. The decision of the Employer in this behalf shall be final and conclusive and binding on the Bidder.

The holding or acquisition of equity or control, as above, shall include direct or indirect holding/ acquisition, including by transfer, of the direct or indirect legal or beneficial ownership or control, by persons acting for themselves or in concert and in determining such holding or acquisition, the Employer shall be guided by the principles, precedents and definitions contained in the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 1997, or any substitute thereof, as in force on the date of such acquisition.

The Bidder shall promptly inform the Employer of any change in the shareholding, as above, and failure to do so shall render the Bidder liable for disqualification from the Bidding Process.

2.2.15 Notwithstanding anything to the contrary contained herein, in the event that the Bid Due Date falls within three months of the closing of the latest financial year of a Bidder, it shall ignore such financial year for the purposes of its Bid and furnish all its information and certification with reference to the 5 (five) years or 1 (one) year, as the case may be, preceding its latest financial year. For the avoidance of doubt, financial year shall, for the purposes of a Bidder hereunder, mean the accounting year followed by the Bidder in the course of its normal business.

### 2.3 Change in composition of the Joint Venture

2.3.1 Change in the composition of a Joint Venture will not be permitted by the Employer during the Bid Stage.

### 2.4 Number of Bids and costs thereof

- 2.4.1 No Bidder shall submit more than one Bid for the Project (not applicable to Part-A Scope of work). A Bidder applying individually or as a member of a Joint Venture shall not be entitled to submit another bid either individually or as a member of any Joint Venture, as the case may be (not applicable to Part-A Scope of work).
- 2.4.2 The Bidders shall be responsible for all of the costs associated with the preparation of their Bids and their participation in the Bid Process. The Employer will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

### 2.5 Site visit and verification of information

Bidders are encouraged to submit their respective Bids after visiting the Project site and ascertaining for themselves the site conditions, traffic, location, surroundings, climate, availability of power, water and other utilities for construction, access to site, handling and storage of materials, weather data, applicable laws and regulations, and any other matter considered relevant by them.

# 2.6 Acknowledgement by Bidder

- 2.6.1 It shall be deemed that by submitting the Bid, the Bidder has:
  - (a) made a complete and careful examination of the RFP;
  - (b) received all relevant information requested from the Employer;
  - (c) accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Employer relating to any of the matters referred to in Clause 2.5 above; and
  - (d) agreed to be bound by the undertakings provided by it under and in terms hereof.
  - (e) Deleted
- 2.6.2 The Employer shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the Bidding Process, including any error or mistake therein or in any information or data given by the Employer.

# 2.7 Right to accept or reject any or all Bids

2.7.1 Notwithstanding anything contained in this RFP, the Employer reserves the right to accept or reject any Bid and to annul the Bidding Process and reject all Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefor. In the event that the Employer rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to

submit fresh Bids hereunder and as specified in Clause 2.21 of this RFP.

- 2.7.2 The Employer reserves the right to reject any Bid:
  - (a) at any time, a material misrepresentation is made or uncovered, or
  - (b) the Bidder does not provide, within the time specified by the Employer, the supplemental information sought by the Employer for evaluation of the Bid.

If the Bidder is a Joint Venture, then the entire Joint Venture may be disqualified/rejected. If such disqualification/rejection occurs after the Bids have been opened and the Lowest Bidder, gets disqualified/rejected, then the Employer reserves the right to:

- (i) invite the remaining Bidders to match the Lowest Bidder/ submit their Bids in accordance with the RFP; (Applicable only for Part B scope of work) or
- (ii) take any such measure as may be deemed fit in the sole discretion of the Employer, including annulment of the Bidding Processes.
- 2.7.3 In case it is found during the evaluation or at any time before signing of the EPC Agreement or after its execution and during the period of subsistence thereof, including the Defects Liability Period, that one or more of the bid conditions have not been met by the Bidder, or the Bidder has made material misrepresentation or has given any materially incorrect or false information, the Bidder shall be disqualified forthwith if not yet appointed as the Contractor either by issue of the LOA or entering into the EPC Agreement, and if the Bidder has already been issued the LOA or has entered into the EPC Agreement, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Employer to the Bidder, without the Employer being liable in any manner whatsoever to the Bidder and without prejudice to any other right or remedy which the Employer may have under this RFP, the Bidding Documents, the EPC Agreement or under applicable law.
- 2.7.4 The Employer reserves the right to verify all statements, information and documents submitted by the Bidder in response to the RFP. Any such verification or lack of such verification by the Employer shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of the Employer thereunder.

# **PART 3 - Manual for Construction Procedures**

### 2.9 Clarifications

2.9.1 Bidders requiring any clarification on the RFP may notify the Employer in writing or by fax and e-mail in accordance with Clause 1.2.8. They should send in their queries before the date specified in the schedule of Bidding Process contained in Clause 1.3. The Employer shall endeavor to respond to the queries within the period specified therein, but no later than 7 (seven) days prior to the Bid Due Date. The

- responses will be sent by fax and/or e-mail. The Employer will forward all the queries and its responses thereto, to all purchasers of the RFP without identifying the source of queries.
- 2.9.2 The Employer shall endeavor to respond to the questions raised or clarifications sought by the Bidders. However, the Employer reserves the right not to respond to any question or provide any clarification, in its sole discretion, and nothing in this Clause shall be taken or read as compelling or requiring the Employer to respond to any question or to provide any clarification.
- 2.9.3 The Employer may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by the Employer shall be deemed to be part of the RFP. Verbal clarifications and information given by Employer or its employees or representatives shall not in any way or manner be binding on the Employer.

# 2.10 Amendment of RFP

- 2.10.1 At any time prior to the deadline for submission of Bid, the Employer may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the RFP by the issuance of Addenda.
- 2.10.2 Any Addendum thus issued will be available on Employers website.
- 2.10.3 In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, the Employer may, in its sole discretion, extend the Bid Due Date.

# C. PREPARATION AND SUBMISSION OF BID

# 2.11 Language

The Bid and all related correspondence and documents in relation to the Bidding Process shall be in English language. Supporting documents and printed literature furnished by the Bidder with the Bid may be in any other language provided that they are accompanied by translations of all the pertinent passages in the English language, duly authenticated and certified by the Bidder. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Bid, the English language translation shall prevail.

# 2.12 Format and signing of Bid

- 2.12.1 The Bidder shall provide all the information sought under this RFP. The Employer will evaluate only those Bids that are received in the required formats and complete in all respects. Incomplete and /or conditional Bids shall be liable to rejection.
- 2.12.2 The Bidder shall provide all the information sought under this RFP. The Employer will evaluate only those Bids that are received physically in the required formats and complete in all respects and Bid Security, document fee, POA and Joint Bidding Agreement are received in hard copies.
- 2.12.3 The Bid shall be typed and signed in indelible blue ink by the authorized signatory of the Bidder. All the alterations, omissions, additions or any other amendments made to the Bid shall be initialed by the person(s) signing the Bid

# 2.13 Sealing and Marking of Bids

2.13.1 The Bidder shall submit the Technical BID & Financial Bid physical copy comprising of the following documents along with supporting documents as appropriate:

- 2.13.4 If the envelopes are not sealed and marked as instructed above, the Employer assumes no responsibility for the misplacement or premature opening of the contents of the Bid and consequent losses, if any, suffered by the Bidder.
- 2.13.5 Bids submitted by fax, telex, telegram or e-mail shall not be entertained and shall be

rejected.

### 2.14 Bid Due Date

- 2.14.1 Technical and Financial Bid comprising of the document listed at 2.13.1 of the RFP shall be submitted on or sufficiently before 1500 hours IST on the Bid Due Date. Documents listed at Clause 2.13.2 of the RFP shall be physically submitted on or sufficiently before 1500 hours IST on the physical submission Date, at the address provided in Clause 2.13.3 in the manner and form as detailed in this RFP. A receipt thereof should be obtained from the person specified in Clause 2.13.3.
- 2.14.2 The Employer may, in its sole discretion, extend the Bid Due Date by issuing an Addendum in accordance with Clause 2.10 uniformly for all Bidders.

### 2.15 Late Bids

Bids received by the Employer after the specified time on the Bid Due Date shall not be eligible for consideration and shall be summarily rejected.

### 2.16 Modifications/ substitution/ withdrawal of Bids

2.16.1 The Bidder may modify, substitute or withdraw its BID after submission prior to the BID Due Date. No BID can be modified, substituted or withdrawn by the Bidder on or after the BID Due Date & Time.

### D. EVALUATION PROCESS

# 2.17 Opening and Evaluation of Bids

### **Evaluation of Technical Bids:**

- 2.17.1 The Employer shall open the Bids at 1530 hours IST on the Bid Due Date, at the place specified in Clause 2.13.3 and in the presence of the Bidders who choose to attend.
- 2.17.2 Technical Bids of those Bidders, who have not submitted their Bid shall not be considered for opening and evaluation.
- 2.17.3 The Employer will subsequently examine and evaluate Technical Bids in accordance with the provisions set out in Section 3.
- 2.17.4 Bidders are advised that qualification of Bidders will be entirely at the discretion of the Employer. Bidders will be deemed to have understood and agreed that no

- explanation or justification on any aspect of the Bidding Process or selection will be given.
- 2.17.5 To facilitate evaluation of Technical BIDs, the Employer may, at its sole discretion, seek clarifications in writing from any Bidder regarding its Technical BID. Such clarification(s) shall be provided within the time specified by the Employer for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- 2.17.6 If a Bidder does not provide clarifications sought under Clause 2.17.5 above within the prescribed time, its Bid may be liable to be rejected. In case the Bid is not rejected, the Employer may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Employer.
- 2.17.7 The Employer reserves the right to reject any Technical BID which is non-responsive as per clause no 2.19 and no request for alteration, modification, substitution or withdrawal shall be entertained by the Employer in respect of such BID.
- 2.17.8 Any information contained in the Bid shall not in any way be construed as binding on the Employer, its agents, successors or assigns, but shall be binding against the Bidder if the Project is subsequently awarded to it on the basis of such information.
- 2.17.9 The Employer reserves the right not to proceed with the Bidding Process at any time without notice or liability and to reject any or all Bid(s) without assigning any reasons.
- 2.17.10 If any information furnished by the Bidder is found to be incomplete, or contained in formats other than those specified herein, the Employer may, in its sole discretion, exclude the relevant project from computation of the Eligible Score of the Bidder.
- 2.17.11 In the event that a Bidder claims credit for an Eligible Project, and such claim is determined by the Employer as incorrect or erroneous, the Employer shall reject such claim and exclude the same from computation of the Eligible Score, and may also, while computing the aggregate Experience Score of the Bidder, make a further deduction equivalent to the claim rejected hereunder. Where any information is found to be patently false or amounting to a material misrepresentation, the Employer reserves the right to reject the Bid in accordance with the provisions of Clauses 2.7.2 and 2.7.3.
- 2.17.12 The Employer will get the BID security verified from the issuing authority and after due verification, the Authority will evaluate the Technical BIDs for their compliance to the eligibility and qualification requirements pursuant to clause 2.2.1 & 2.2.2 of this RFP.
- 2.17.13 After evaluation of Technical Bids by the competent experts from the review committee, the Employer will inform/publish a list of Technically responsive Bidders whose financial bids shall be opened. The Employer shall notify other bidders that they have not been technically responsive. The Employer will not entertain any query or clarification from Applicants who fail to qualify.

### **Evaluation of Financial Bids:**

2.17.14 The Employer shall inform the venue and time of opening of the Financial Bids to the Technically responsive Bidders. The Employer shall open the Financial Bids on date and

time to be informed in this clause in the presence of the authorized representatives of the Bidders who may choose to attend. The Employer shall publically announce the Bid Price quoted by the technically responsive Bidder. The Employer shall prepare a record of opening of Financial Bids.

- 2.17.15 The selection process is designed to select a technically strong team of participants to carry out the scope of work defined in this document.
- 2.17.16The consultants are required to submit both technical and financial proposal. The Maximum points awarded for the technical proposal is 100 points. The financial proposals of those bidders who have scored more than 50 points in their respective technical proposal would only be considered for selection. The evaluation process will be done by a team of experts in desalination industry.
- 2.17.17 The financial bids of the bidders will be opened after intimation of technical scores to each of the bidders during financial opening.
- 2.17.18 Once the financial bids of the technically responsive bidders are opened, the summary of the technical and the financial proposals will be send to DST for evaluation and final selection of technologies. The bidders whose technologies are selected by the DST will be awarded the project.
- 2.17.19 For Part B scope of work, once the technical bids are open, the responsive bids will be sent to a team of desalination experts. The financial bids of bidders whose technical bids are found eligible will be opened and the bid with L1 bid pricing will be sent to the DST for further scrutiny and analysis before finalizing.

# 2.18 Confidentiality

Information relating to the examination, clarification, evaluation, and recommendation for the qualified Bidders shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional advisor advising the Employer in relation to, or matters arising out of, or concerning the Bidding Process. The Employer will treat all information, submitted as part of Bid, in confidence and will require all those who have access to such material to treat the same in confidence. The Employer may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or the Employer or as may be required by law or in connection with any legal process.

# 2.19 Tests of responsiveness

- 2.19.1 Prior to evaluation of Bids, the Employer shall determine whether each Bid is responsive to the requirements of the RFP. A Bid shall be considered responsive only if:
- (a) it is received as per format at Appendix-I (A) and I(B).
- (b) it is received by the Bid Due Date including any extension thereof pursuant to Clause 2.14.2;

- (c) it is signed, sealed, bound together in hard cover, and marked as stipulated in Clauses 2.12 and 2.13;
- (d) it is accompanied by the Power of Attorney as specified in Clause 2.2.5, and in the case of a Joint Venture, the Power of Attorney as specified in Clause 2.2.6;
- (e) it contains all the information and documents (complete in all respects) as requested in this RFP;
- (f) it contains information in formats same as those specified in this RFP;
- (g) it contains certificates from its statutory auditors in the formats specified at Appendix-IA of the RFP for each Eligible Project;
- (h) it contains a Demand draft issued by any scheduled bank in India for [Rs. ..... (Rupees ......only)] to Employer towards the cost of the RFP process;
- (i) it is accompanied by the Jt. Bidding Agreement (for Joint Venture), specific to the Project, as stipulated in Clause 2.2.6;

### 2.21 Selection of Bidder

2.21.1 For Part A scope of work the selection of bidders will be based on the evaluation criteria mentioned in the tender document. Project proposal submissions which has received a minimum of 50 marks will be reviewed by a team of desalination experts (Technical committee), for the merit of the proposal meeting the objectives of the project. If the technical committee finds merit in the project, the financial bid of the respective bidder

will be opened. Once all the selected successful bidders are selected, based on the above criteria, the list of technologies and the respective cost of the project will be sent for final approval from DST. The project has options to select a maximum of 5 different technologies for part A scope of work. For the scope of work under part B, the bidder who quotes the lowest price for scope of work in Part B of this tender document in complete will be awarded the project after the approval process from DST.

In the event that the Employer rejects or annuls all the BIDs, it may, in its discretion, invite all eligible Bidders to submit fresh BIDs hereunder.

- 2.21.9 The Financial Proposals of only those consultants who have scored the minimum marks in the technical proposals shall be opened
- 2.21.10 The Financial Proposals will be opened publicly in the presence of the consultants' representatives who choose to attend.
- 2.21.11 The shortlisted bids will be sent to DST for their internal committee to review and finalize the award based on technical and financial merit of the project in line with the project objectives.

# 2.22 Proprietary data

All documents and other information supplied by the Employer or submitted by a Bidder to the Employer shall remain or become the property of the Employer. Bidders are to treat all information as strictly confidential and shall not use it for any purpose

other than for preparation and submission of their Bid. The Employer will not return any Bid or any information provided along therewith.

# 2.23 Correspondence with the Bidder

Save and except as provided in this RFP, the Employer shall not entertain any correspondence with any Bidder in relation to the acceptance or rejection of any Bid.

# 2.24 Contacts during BID Evaluation

BIDs shall be deemed to be under consideration immediately after they are opened and until such time the Employer makes official intimation of award/ rejection to the Bidders. While the BIDs are under consideration, Bidders and/ or their representatives or other interested parties are advised to refrain, save and except as required under the Bidding Documents, from contacting by any means, the Employer and/ or their employees/ representatives on matters related to the BIDs under consideration.

a) The above should be supported by relevant documentary evidence. The certificates (work order and Work Completion Certificates) issued by the clients shall form basis for

considering experience of work executed.

b) Audited Financial Statements (P&L statement and Balance Sheets) are to be submitted for indicating the financial capabilities.

Feasibility analysis of RE integrated desalination system with efficient power utilization and integration with battery energy storage systems (BESS) in smart grid configuration.

### 3.7 Technical committee

- 3.7.1 A technical committee consisting of renowned experts from desalination industry from India and abroad will be formed to evaluate the proposal and its expected outcomes. The technical committee shall review the submitted technical proposals against the expected outcomes in line with the Key Performance Indicators (KPI's).
- 3.7.2 The selected technologies will be demonstrated for a period of minimum 12 months. The technical committee will review the performance of the plant against the anticipated results for the period of the demonstration cycle against the KPI's.

### 4. FRAUD AND CORRUPT PRACTICES

- 4.1 The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process. Notwithstanding anything to the contrary contained herein, the Employer may reject a Bid without being liable in any manner whatsoever to the Bidder if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process.
- 4.2 Without prejudice to the rights of the Employer under Clause 4.1 hereinabove, if a Bidder is found by the Employer to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, such Bidder shall not be eligible to participate in any tender or RFP issued by the Employer during a period of 2 (two) years from the date such Bidder is found by the Employer to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.
- 4.3 For the purposes of this Clause 4, the following terms shall have the meaning hereinafter respectively assigned to them:

- (a) Such Party is duly organized, validly existing and in good standing under the laws of its incorporation and has all requisite power and authority to enter into this Agreement;
- (b) The execution, delivery and performance by such Party of this Agreement has been authorized by all necessary and appropriate corporate or governmental action and a copy of the extract of the charter documents and board resolution/ power of attorney in favour of the person executing this Agreement for the delegation of power and authority to execute this Agreement on behalf of the Joint Venture Member is annexed to this Agreement, and will not, to the best of its knowledge:

- (i) require any consent or approval not already obtained;
- (ii) violate any Applicable Law presently in effect and having applicability to it;
- (iii) violate the memorandum and articles of association, by-laws or other applicable organizational documents thereof;
- (iv) violate any clearance, permit, concession, grant, license or other governmental authorization, approval, judgment, order or decree or any mortgage agreement, indenture or any other instrument to which such Party is a party or by which such Party or any of its properties or assets are bound or that is otherwise applicable to such Party; or

### OFFICE MEMORANDUM

Sub: Guidelines for qualification of Bidders seeking to acquire stakes in Public Sector Enterprises through the process of disinvestment

Government has examined the issue of framing comprehensive and transparent guidelines defining the criteria for bidders interested in PSE-disinvestment so that the parties selected through competitive bidding could inspire public confidence. Earlier, criteria like net worth, experience etc. used to be prescribed. Based on experience and in consultation with concerned departments, Government has decided to prescribe the following additional criteria for the qualification/ disqualification of the parties seeking to acquire stakes in public sector enterprises through disinvestment:

- (a) In regard to matters other than the security and integrity of the country, any conviction by a Court of Law or indictment/ adverse order by a regulatory Employer that casts a doubt on the ability of the bidder to manage the public sector unit when it is disinvested, or which relates to a grave offence would constitute disqualification. Grave offence is defined to be of such a nature that it outrages the moral sense of the community. The decision in regard to the nature of the offence would be taken on case to case basis after considering the facts of the case and relevant legal principles, by the Government of India.
- (b) In regard to matters relating to the security and integrity of the country, any charge-sheet by an agency of the Government/ conviction by a Court of Law for an offence committed by the bidding party or by any sister concern of the bidding party would result in disqualification. The decision in regard to the relationship between the sisters concerns would be taken, based on the relevant facts and after examining whether the two concerns are substantially controlled by the same person/ persons.
- (c) In both (a) and (b), disqualification shall continue for a period that Government deems appropriate.

<sup>&</sup>lt;sup>11</sup> These guidelines may be modified or substituted by the Government from time to time.

- (d) Any entity, which is disqualified from participating in the disinvestment process, would not be allowed to remain associated with it or get associated merely because it has preferred an appeal against the order based on which it has been disqualified. The mere pendency of appeal will have no effect on the disqualification.
- (e) The disqualification criteria would come into effect immediately and would apply to all bidders for various disinvestment transactions, which have not been completed as yet.
- (f) Before disqualifying a concern, a Show Cause Notice why it should not be disqualified would be issued to it and it would be given an opportunity to explain its position.
- (g) Henceforth, these criteria will be prescribed in the advertisements seeking Expression of Interest (EOI) from the interested parties. The interested parties would be required to provide the information on the above criteria, along with their Expressions of Interest (EOI). The bidders shall be required to provide with their EOI an undertaking to the effect that no investigation by a regulatory authority is pending against them. In case any investigation is pending against the concern or its sister concern or against its CEO or any of its Directors/ Managers/ employees, full details of such investigation including the name of the investigating agency, the charge/ offence for which the investigation has been launched, name and designation of persons against whom the investigation has been launched and other relevant information should be disclosed, to the satisfaction of the Government. For other criteria also, a similar undertaking shall be obtained along with EOI.
